- All programs must be biblically and psychologically sound. CCT will verify each program as to its creditability for Continuing Education Units.

Return the following materials with this completed form:

1. **One Page Abstract:** Include purpose, objectives, needs addressed, and intended audience. It is essential to indicate the mature application of psychology and theology as part of the workshop.
2. **One Paragraph Workshop Description:** The paragraph should be between 75-85 words in length. This will appear in the program as submitted.
3. **One Complete Set of Handouts:** All handouts must be reviewed and approved before conference.
4. **Brief Resume of Presenter/Co-Presenters:** Include why you are qualified to present this information to the intended audience.
5. **Paragraph Relating to Your Christian Walk:** Include your calling, vision, ministry, and current church involvement.
6. **Signed Presenter Agreement.** (see next page)

Co-presenters are **required** to submit separate applications and items #4-6 above.

As a candidate to be an approved program presenter at the Annual State Conference of the Christian Counselors of Texas, Inc., I indicate by signing below that I/we agree without reservation:

1. With the CCT Statements of Belief and Purposes, as follows:
